

**PROCEDURE FOR PROVISIONAL ADMISSION
(STD. XI) INTERNAL CANDIDATES
ACADEMIC YEAR 2022-23**

1. The duly filled in google form (Registration Form), should be submitted on or before **13/12/2021**.
2. Single registration is only valid. Multiple entries by any candidate will be treated as cancelled.
3. Subject combination : -

4. Eligibility Criteria : -

Science Stream	75% Aggregate in English, Mathematics, Science, Social Science, Hindi/Sanskrit.
Commerce Stream	65% Aggregate in English, Mathematics, Science, Social Science, Hindi/Sanskrit.
Arts Stream	65% Aggregate in English, Mathematics, Science, Social Science, Hindi/Sanskrit.

5. All the details in the application form should be as per the registration in CBSE.
6. Stream will be allotted for provisional admission in Std. XI on the basis of the result of Term-I Board Examination (2021-22).
7. The candidates will be required to take provisional admission on payment of ₹40,000/-. (Payment will be accepted only through the link provided by the school. Admission will be confirmed within 3 days of the declaration of Xth Board results (Term-II) subject to meeting the requisite eligibility criteria on payment of the fee as per the fee structure.
8. Classes for Std. XI (Session 2022-23) will immediately start after Term II AISSE-2022.
9. In case of non-fulfillment of the eligibility criteria after the declaration of the **Class X Results - 2022**, the Provisional Admission would stand cancelled.
10. **Special waivers for students qualified in NTSE and various Olympiads.**
11. Bus facility will be provided if there is vacancy.
12. The amount paid at the time of Provisional Admission will be refunded (after relevant deductions) only to those who **do not meet the eligibility criteria mentioned in Point 4.**
13. The School Management reserves the right to add, alter, amend or cancel any of the rules, procedures prevailing at any time which will be binding on the students, parents/guardian.
